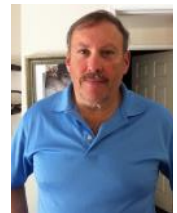

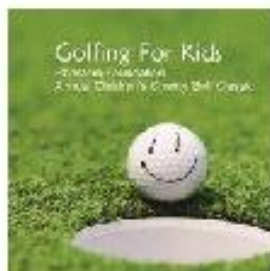

Prospective Rooster – Thad Sanford (Marty Burbank)

Thad Sanford retired from the Boeing Company in May 2004, as vice president for Engineering for the Boeing Integrated Defense Systems (Boeing's Defense and Space Businesses). He joined Rockwell International in 1989 and became a Boeing employee when Boeing bought Rockwell's aerospace businesses in 1996. In that period, he had a series of positions on increasing responsibilities in both Engineering management and program management positions in the development of advanced air and space systems.

Thad retired as a Colonel with twenty-six years of service in the Air Force. His assignments were almost exclusively in Research and Development. During those years he was stationed at Palo Alto, California; Vandenberg AFB, Wright Patterson AFB Ohio; Andrews AFB, Maryland, The Pentagon, and Hanscom AFG, Mass.

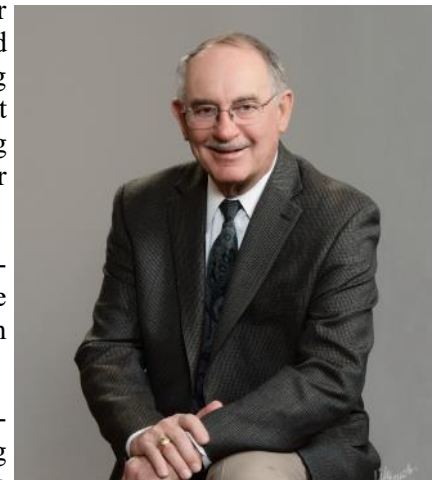
He has served on Engineering councils for the University of Tennessee Space Institute; USC; and UCLA. He also on Texas A&M Dept of Mechanical Engineering Development and Advisory Council, and as chair from 2002-2004. He is currently a

member of the advisory council for the school of engineering at University of California, Riverside. He also currently serves as chair of the Infrastructure Committee for the City of Fullerton, Member of First United Methodist Church of Fullerton, Member of St Jude Memorial Hospital Foundation, Member of Rotary, and Member of Rotary Club of Fullerton.

Thad was recognized as an Honorary Senior Technical Fellow of the Boeing Company, in Feb 2004, as one of only six management people so honored in the history of the Boeing Co. Additional recognitions include the National Management Association Golden Knight award, 2003, and the Amelia Earhart Award, 2002. He was awarded the Legion of Merit, with one oak leaf cluster; and the meritorious service medal, with two oak leaf clusters while in the Airforce. In 1999, Thad was honored as Member of the Academy of Distinguished Graduates of Texas A&M Dept of Mechanical Engineering.

Thad was born in Fairbanks, Alaska and raised in Cleburne, Texas. He received his B.S. from Texas A&M in 1963; M.S. from University of Tennessee Space Institute in 1966, and PhD in Aerospace Engineering at Texas A&M in 1973. He is also a graduate of the Naval War College (command and staff) in 1976, with highest honors; and of the National War College in 1982.

Thad and his wife, Ann, live in Fullerton, Calif. They have two grown children and four grandchildren.

Susan is the wife of Rooster Dan Ouweleen and was invited by the Orange County YWCA to speak at a luncheon about "Her Story Matters."



Susan shared her inspirational journey about her family of 9 children surviving the communist Khmer Rouge government in Cambodia led by Pol Pot from 1975 to 1979.

During that time, an estimated 1.5 to 2 million Cambodians died of starvation, execution, disease or overwork, including two of her brothers. Her family was flown by the Red Cross to LAX with nothing but the clothes on their backs.

They settled and ended up owning 3 donut shops. Susan worked in them starting at 4. She worked her way through college and graduated from Cal State Fullerton. Today, she is a successful businesswoman who owns and operates Assured Audiovisual Inc.
